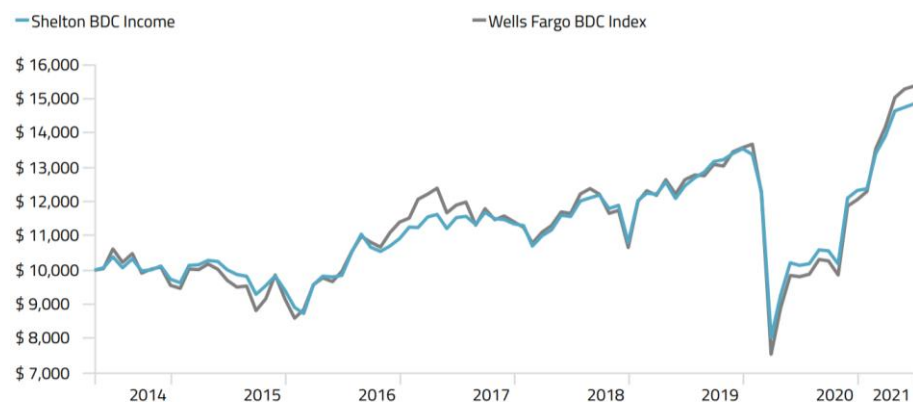
The Fund's investment objective is to provide a high level of income with the potential for capital appreciation.

Fund expenses include the indirect costs of investing in other investment companies, which were 9.91% per each class of shares. The Fund's Advisor, Shelton Capital Management (the "Advisor"), has contractually agreed to reimburse expenses incurred by the Fund to the extent that total annual fund operating expenses (excluding acquired fund fees and expenses, certain compliance costs, and extraordinary expenses such as litigation or merger and reorganization expenses, for example) exceed 1.25% and 1.50% until May 1, 2022.

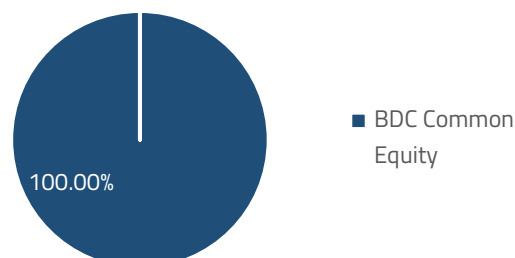
