

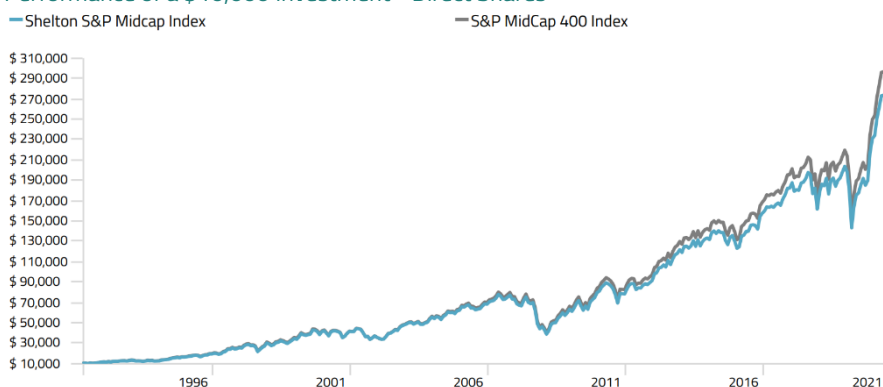
Fund Objective
