

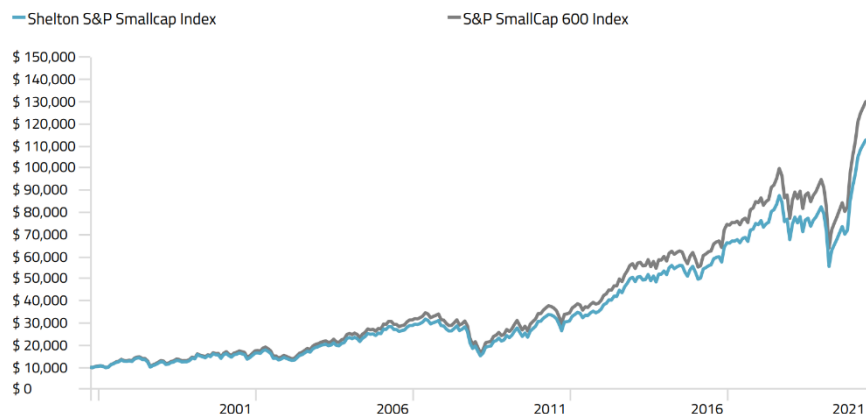
Fund Objective
